# Excerpt from Aug 26 BOS meeting.

Bruce Sanborn, 115 Twist Hill Road spoke on behalf of the WHS. He shared the WHS's need for more space. The organization is seeking to pursue different opportunities. The WHS would like to know if the town offices at 9 Kearsarge Valley Road would be available in the next three to five years as it would be an ideal location for the historical society. The WHS would like to start a dialog about the future of the town and its facilities. The WHS would like to have a larger space and permanent home in three to five years. The WHS would like there to be a discussion about future uses of properties like 14 North Wilmot Road. Might there be an option for the WHS to that that space? The WHS also posed the third option might be another town owned parcel that they might not be aware of.

Catherine Stearns, 178 Stearns Road and Vice President of WHS, noted there are lots of new people moving to town, and many are looking for historical information about their homes, WHS is a great resource for this information.

Elizabeth Kirby, 172 Cross Hill Road and President of WHS - regarding the timeframe in which they would like to have a permanent location with more space times possibly with the Wilmot highway garage loan being paid off in 2026 and maybe a town office complex be considered at that time.

Chairman Schamberg encouraged the WHS to put together more detailed information about their ideas. Selectboard member Hart noted there weren't any plans to move the town offices in the works, so the WHS might want to pursue other options. She noted there might be a structure that could be moved to a location like the 14 North Wilmot Road property.

The Selectboard thanked Sanborn for his presentation and for bringing the issue to the board.
